Membership

REGULAR - \$50

- All CPA's in the Philippines or in the United States, Chartered Accountants in Canada or local equivalent of these certifications in other parts of the world, who are of Filipino descent or who may not be of Filipino descent but who believe in the objectives and goals of the Society;
- Must be in the practice of the accounting profession either in public accounting or employed in private or government entities as an accountant or similar financial function

ASSOCIATE - \$40

- Members under this category include all non-CPA's, but holder of Bachelor's degree in business or related field, and are employed in CPA firms, private industries or government entities as accountants or similar financial functions. Associate Members cannot hold any elected positions until their membership is changed to Regular Member status.

STUDENT - \$10

- Students who are currently enrolled in an accredited university and are majoring in accounting or any business related courses or are in the process of taking the CPA examination qualify as Student Members. Student Members cannot hold any elected positions until their membership is changed to Regular Member status.

ADVISOR/MENTOR - \$50

- Advisor/Mentor Member - Members who possess the level of experience to guide new members and elect not to be regular members will be classified as Advisor/Mentor Members. These members cannot hold elected positions, but shall serve as advisors/mentors to the officers, Regular, Associate, and Student Members.

HONORARY

- Honorary membership is by invitation only and shall be extended to an individual who has achieved eminent success in the accounting or related profession (e.g., partner in a CPA firm, CFO in a private industry, etc.). Honorary members cannot hold any elected positions in the Society. Acceptance as honorary member is subject to the approval of the Board of Directors
